

**BRIEF WRITE-UP ON CENTRALLY SECTOR / SPONSORED AND OTHER SCHEMES
UNDER LABOUR DEPARTMENT**

A. CENTRALLY SECTOR SCHEMES

1. **Enhancing Skill Development Infrastructure (ESDI) in NE Region and Sikkim – Upgradation of Existing ITIs:** Funding Pattern is 100% Central Assistance. The Scheme has two components: Upgradation & Supplementing Deficient Infrastructure and Introduction of New Trades. Four existing Govt., ITIs at Sohra, Resubelpara, Nongpoh & Nongstoin are covered under this Scheme. The Scheme is implemented by the State Council for Training in Vocational Trades (SCTVT) Society.

2. **Skill Development Initiative (SDI) Scheme** – Funding Pattern is 100% Central Assistance. The scheme “Skill Development” of the m/o Skill Development & Entrepreneurship, Govt., of India has been included in the mapping of schemes proposed to be implemented in Twelfth Five Year Plan. An Institutional Training through the registered Vocational Training Providers (VTPs). MES is the “minimum skill set” which is sufficient to get an employment in the world of work. MES allows Skills Upgradation. It also allows multi-entry and multi-exit. The Educational qualification varies from Class V pass to Class XII pass depending upon the MES Courses. The Duration of Training varies from 50 hours to 1200 hours. The skill is to be assessed by the Assessing Body mainly from the Industry Organization. Certification is done jointly by the National Council for Vocational Training and Industry (Assessing Body). All Vocational Training Providers (VTPs) registered with the State (located within and outside the State) are covered under this scheme. The scheme is implemented by the State Council for Training in Vocational Trades (SCTVT) Society.

3. **Setting up of a Model Career Centre:** Funding Pattern is 100% Central Assistance. The Government of India has recently approved the setting up of a Model Career Centre at Shillong at a Project Cost of Rs.50/- Lakhs. The Government of India has sanctioned and released the first instalment for the setting-up of a Model Career Centre in Shillong. The Employment Exchanges function will focus more to provide relevant employment counselling, assessment of capabilities and vocational guidance to the job` seekers for improving their employability.

ITIs under the Vocational Training Improvement Project (VTIP) with World Bank Assistance** – Funding Pattern is 90:10 (Central:State) – General Upgradation of Existing Trades and Introduction of three new trades viz., Draughtsman (Civil), Draughtsman (Mechanical) and Surveyor. Govt., ITI Tura is covered under this scheme.

- 2. Enhancing Skill Development Infrastructure (ESDI) in NE Region and Sikkim – Setting-up of New ITI at Ampati:** Funding Pattern is 90:10 (Central:State) - first installment sanctioned and transferred to the account of the State Council for Training In Vocational Trades Society. Land for construction of Buildings has been identified. Notice for Inviting Tender for Procurement of Tools, Equipments, Machineries and Furniture in process. Approval for creation of posts on Contractual Basis is awaited.

The scheme is implemented by the State Council for Training in Vocational Trades (SCTVT) Society.

- 3. ADB Project ‘Supporting Human Capital Development in Meghalaya’** - The key objective of PIU-3 is to strengthen the Industrial Training Institutes (ITIs) in the State of Meghalaya. The Project is for Upgradation and Reforming of Govt., it is through Upgradation of Infrastructure & Equipments and Training of Trainers.
