1. The Chairman welcomed the members of the Selection Committee including the Bidder's Representative whose technical bid had achieved the minimum technical score as per the Quality Cost Based Selection Method (QCBS).
2. Accordingly, it was made aware to all the members present that there were three bids received, namely CRISP Bhopal, IPE Global Limited, New Delhi and Process and Product Development Centre (PPDC) Indore. Upon evaluation of the same, only two bids that was submitted by CRISP Bhopal and IPE Global Limited New Delhi respectively was found to have achieved the minimum technical scoring in order to have their financial bids opened.
3. In adherence to the Bid Document requirement, the names of the bidders, and the overall technical scores, including the break-down by criterion, was read out aloud.
4. This was followed by the inspection of the Financial Proposals so as to confirm that they have remained sealed and unopened.
5. The Financial Proposals was opened, and the prices quoted against each firm has been read out aloud and recorded accordingly.
6. It was then informed by the Chair that the financial evaluation of the financial proposals will be assessed and evaluated accordingly as per the Bid Document, the copies of the record will be shared with all the Bidders.


