- 1) The Director of Employment & Craftsmen Training welcomed all the Officers and the Bidder's Representative present in the Price Bid Opening.
- 2) The Director of Employment & Craftsmen Training confirmed Package-wise receipt of Financial Proposals as follows:

I. Package 55 (4):

This package consisting of four (4) lots, had the respective bidders:

Lot 1: consisted of one bidder, i.e., Royal Electronic Sales and Services, whose price bid was not opened since its technical bid was found to be non-responsive.

Lot 2: consisted of two bidders, i.e., NCCF of India Ltd., and Greta Solutions.

Lot 3: consisted of one bidder, i.e., Indian Export and Import Co.

Lot 4: consisted of one bidder, i.e., Greta Solutions.

II. Package 56 (7):

This Package consisting of two (2) lots, had the respective bidders:

Lot 1: consisted of two bidders, i.e., Kuber Techno Craft and Greta Solutions. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

Lot 2: consisted of three bidders, i.e., Kuber Techno Craft, NCCF of India Ltd and Greta Solutions. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

V. Package 63 (5):

This Package consisting of four (4) lots, had the respective bidders:

Lot 1: consisted of one bidder, i.e., NCCF of India Ltd.

Lot 2: consisted of two bidders, i.e., NCCF of India Ltd., and Greta Solutions.

Lot 3: consisted of one bidder, i.e., Indian Export and Import Co.

Lot 4: consisted of one bidder, i.e., NCCF of India Ltd.

VI. Package 64 (10):

This Package consisting of four (4) lots, had the respective bidders:

Lot 1: consisted of four bidders, i.e., Kuber Techno Craft, NCCF of India Ltd, Royal Electronic Sales and Services and Grace Scientific Corporation. Kuber Techno Craft and Grace Scientific Corporation's price bids were not opened since their technical bid was found to be non-responsive.

Lot 2: consisted of two bidders, i.e., Kuber Techno Craft and Greta Solutions. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

Lot 3: consisted of two bidders, i.e., Kuber Techno Craft and Indian Export and Import Co. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

Lot 4: consisted of two bidders, i.e., Kuber Techno Craft and Greta Solutions. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

VII. Package 65 (11):

This Package consisting of four (4) lots, had the respective bidders:

Lot 1: consisted of four bidders, i.e., Kuber Techno Craft, NCCF of India Ltd, Royal Electronic Sales and Services in JV with VPL Infotech & Consultants, and Puri Scientific Works in JV Grace Scientific Corporation. Royal Electronic Sales and Services in JV with VPL Infotech & Consultants, and Puri Scientific Works in JV with Grace Scientific Corporation's price bid was not opened since their technical bid was found to be non-responsive.

Lot 2: consisted of three bidders, i.e., Kuber Techno Craft, NCCF of India Ltd and Greta Solutions.

Lot 3: consisted of two bidders, i.e., Kuber Techno Craft and Indian Export and Import Co, of which Kuber Techno Craft's was not opened as it was deemed non-responsive.

Lot 4: consisted of four bidders, i.e., Kuber Techno Craft, NCCF of India Ltd, Greta Solutions, and Puri Scientific Works in JV with Grace Scientific Corporation.

VIII. Package 66 (12):

This Package consisting of four (4) lots, had the respective bidders:

Lot 1: consisted of three bidders, i.e., Kuber Techno Craft, NCCF of India Ltd and Royal Electronic Sales and Services. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

Lot 2: consisted of three bidders, i.e., Kuber Techno Craft, NCCF of India Ltd and Greta Solutions. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

Lot 3: consisted of two bidders, i.e., Kuber Techno Craft and Indian Export and Import Co. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

Lot 4: consisted of three bidders, i.e., Kuber Techno Craft, NCCF of India Ltd and Greta Solutions. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

IX. Package 67 (13):

This Package consisting of three (3) lots, had the respective bidders:

Lot 1: consisted of four bidders, i.e., Kuber Techno Craft, Royal Electronic Sales and Services, Greta Solutions, and Puri Scientific Works.

Lot 3: consisted of three bidders, i.e., Kuber Techno Craft, Greta Solutions and Indian Export and Import Co. Kuber Techno Craft's price bid was not opened since its technical bid was found to be non-responsive.

X. Package 68 (15):

This Package consisting of three (3) lots, had the respective bidders:

Lot 1: consisted of two bidders, i.e., Puri Scientific Works and Greta Solutions.

Lot 2: consisted of two bidders, i.e., Indian Export and Import Co and Greta Solutions. Greta Solutions' price bid was not opened since its technical bid was found to be non-responsive.

Lot 3: consisted of one bidder, i.e., Greta Solutions.


